## 1. Description

GuardIT® Paving & Concrete Cleaner is a heavy-duty, water-based cleaner containing a revolutionary, high-performance soy solvent for the safe removal of industrial grease, heavy oil build-up, dirt, and grime from hard surfaces including tiles, concrete, brick, and other surfaces.

## 2. Key Attributes

## 3. Suitable Surfaces

Caution: Paving & Concrete Cleaner is not suitable to be used on any polished surfaces. Care to be taken when working around sensitive metals such as zinc, zincalume, alloys, chrome, and aluminium.

## 4. Storage & Shelf Life

---

Please store the unopened container in a cool, dry place, away from direct sunlight, and out of reach of children. For best results, maintain a temperature between 3°C and 30°C during storage and transport.

Use the product within 2 to 4 years under these conditions. Effectiveness may begin to decrease after this period.

Some liquid preparations settle or separate on standing and may require stirring before use.

## 5. Preparation

---

Ensure the surface is free from loose debris before application. Always test on a small, inconspicuous area first to check compatibility and dilution rate appropriate to the application.

General Maintenance: Recommended dilution rate is 250ml to 10 litres of water (1:40).

Heavily Soiled Areas: Recommended dilution rate is 1 litre to 10 litres of water (1:10).

## 6. Application Instructions

---

Thoroughly wet the surface with clean water. Apply the diluted solution to the surface using a broom or soft-bristled brush. Allow the product to dwell for several minutes to penetrate grease and grime. Agitate the area with the broom or brush to loosen contaminants, then rinse thoroughly with clean water.

## 7. Safety

---

Please ensure that the area being treated is well-ventilated. When applying outdoors, avoid doing so in windy conditions.

- **Inhalation:** No first aid measures normally required. If in doubt, contact a Poisons Information Centre or a doctor.
- **Skin Contact:** Gently blot away excess liquid. Irritation is unlikely. However, if irritation does occur, flush with lukewarm, gently flowing water for 5 minutes or until chemical is removed.
- **Eye Contact:** Immediately flush the contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed, while holding the eyelid(s) open. No effects expected. Obtain medical advice immediately if irritation occurs. Take special care if exposed person is wearing contact lenses.

- **Ingestion:** If product is swallowed or gets in mouth, do NOT induce vomiting; wash mouth with water and give some water to drink. If symptoms develop, or if in doubt, contact a Poisons Information Centre or a doctor.

Advice to doctor: Treat symptomatically.

As with any chemical: Ingestion, inhalation, and prolonged or repeated skin contact should be avoided by good occupational work practice.
